## AMENDMENT TWO TO CONTRACT BETWEEN THE DEPARTMENT OF ECONOMIC OPPORTUNITY AND TECH VALLEY TALENT, LLC

On June 15, 2022, the State of Florida, Department of Economic Opportunity ("DEO"), and Tech Valley Talent, LLC ("Contractor"), entered into Contract Number C3319 ("Contract") for Information Technology Independent Verification and Validation (IV&V) services necessary to assist in the development of the consumer-first workforce system. DEO and Contractor may hereinafter be referred to individually as a "Party" and collectively as "the Parties."

**WHEREAS,** Section I.E.7, Renewal and Extension, of the Contract provides that the Contract may be renewed for a period not to exceed the original term of the Contract; and

**WHEREAS,** Section II.A., Renegotiation or Modification, of the Contract provides that any amendment to the Contract shall be in writing and executed by the Parties thereto;

WHEREAS, the Parties amended the Contract on June 27, 2022 to revise the Contract's effective date; and

WHEREAS, the Parties wish to amend the Contract and renew the Contract for one (1) year as set forth herein;

**NOW THEREFORE,** in consideration of the mutual covenants and obligations set forth herein, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to the following:

- 1. Section I.C., Contract Dates, of the Contract is hereby deleted in its entirety and replaced with the following:
  - This Contract is effective as of July 1, 2022, and shall remain in effect through June 30, 2024, unless otherwise terminated pursuant to Section II.C., Termination. DEO shall not be obligated to pay for costs incurred related to this Contract prior to its beginning date or after its ending date.
- 2. Section I.F.1.a., within the "Governing Laws" section of the Contract, is hereby incorporated by reference as if fully restarted herein.
- 3. All other terms and conditions of the Contract remain in effect.
