# <u>ORDER</u>

This matter comes before me for final Agency Order.

An Order to Show Cause mailed to the Petitioner on January 21, 2011, provided fifteen (15) calendar days for the Petitioner to explain why its protest filed November 12, 2010, should be considered a timely appeal to the determination dated September 14, 2010. The Petitioner submitted a written response to the Order to Show Cause on February 11, 2011. Rule 60BB-2.035(5) of the Florida Administrative Code requires that a protest be dismissed if the Petitioner does not provide written evidence that the protest is timely within 15 days of the issuance of the Order to Show Cause. Since the Petitioner's response did not provide written evidence that the protest was timely filed and the response was not received within 15 days of the of the mailing of the Order to Show Cause, the Petitioner's protest is dismissed pursuant to rule 60BB-2.035(5), Florida Administrative Code.
