# **ORDER**

This matter comes before me for final Department Order.

An *Order to Show Cause* mailed to the Petitioner on November 27, 2012, provided fifteen (15) calendar days for the Petitioner to explain why its protest dated November 1, 2012, should be considered a timely appeal to the determination dated September 4, 2012. Since no evidence of timely filing was received within 15 days after the mailing date of the *Order to Show Cause*, the Petitioner's protest is dismissed pursuant to rule 73B-10.035(5), Florida Administrative Code.

In consideration thereof, it is ORDERED that the Petitioner's protest of the determination dated September 4, 2012, is dismissed due to lack of jurisdiction.

## **JUDICIAL REVIEW**

Any request for judicial review must be initiated within 30 days of the date the Order was filed. Judicial review is commenced by filing one copy of a *Notice of Appeal* with the DEPARTMENT OF ECONOMIC OPPORTUNITY at the address shown at the top of this *Order* and a second copy, with filing fees prescribed by law, with the appropriate District Court of Appeal. It is the responsibility of the party appealing to the Court to prepare a transcript of the record. If no court reporter was at the hearing, the transcript must be prepared from a copy of the Special Deputy's hearing recording, which may be requested from the Office of Appeals.
