ORDER

Having fully considered the Special Deputy's Recommended Order and the record of the case, and in the absence of any exceptions to the Recommended Order, I hereby adopt the Findings of Fact and Conclusions of Law as set forth therein. A copy of the Recommended Order is attached and incorporated in this Final Order.

In consideration thereof, it is ORDERED that the Petitioner's protest of the determination dated December 13, 2011, is dismissed due to lack of jurisdiction.

JUDICIAL REVIEW

Any request for judicial review must be initiated within 30 days of the date the Order was filed. Judicial review is commenced by filing one copy of a *Notice of Appeal* with the DEPARTMENT OF ECONOMIC OPPORTUNITY at the address shown at the top of this *Order* and a second copy, with filing fees prescribed by law, with the appropriate District Court of Appeal. It is the responsibility of the party appealing to the Court to prepare a transcript of the record. If no court reporter was at the hearing, the transcript must be prepared from a copy of the Special Deputy's hearing recording, which may be requested from the Office of Appeals.

RECOMMENDED ORDER OF SPECIAL DEPUTY

TO: Assistant Director,
Interim Executive Director,
Unemployment Compensation Services
DEPARTMENT OF ECONOMIC OPPORTUNITY

This matter comes before the undersigned Special Deputy pursuant to the Petitioner's protest of the Respondent's determination dated December 13, 2011.

After due notice to the parties, a telephone hearing was held on May 21, 2012. The Petitioner, represented by the General Manager, appeared and testified. The Human Resource Manager participated as a witness. The Respondent, represented by a Department of Revenue Tax Specialist I, appeared and testified.

The record of the case, including the recording of the hearing and any exhibits submitted in evidence, is herewith transmitted. Proposed Findings of Fact and Conclusions of Law were not received.

Issue:

Whether the Petitioner's tax rates were properly computed, pursuant to Section 443.131, Florida Statutes; Rules 73B-10.026; 10.031, Florida Administrative Code.

Whether the Petitioner filed a timely protest pursuant to Sections 443.131(3)(i); 443.141(2); 443.1312(2), Florida Statutes: Rule 73B-10.035, Florida Administrative Code.

Whether the Petitioner's liability for unemployment compensation contributions was properly determined pursuant to Sections 443.1215, 1216, 1217; 443.131, Florida Statutes.

Findings of Fact:

- 1. By *Unemployment Compensation Tax Rate Notice* mailed on or before December 13, 2011, the Department of Revenue notified the Petitioner of the Petitioner's unemployment compensation tax rate effective January 1, 2012.
- 2. The *Unemployment Compensation Tax Rate Notice* was mailed to the Petitioner's correct address of record and was received. Among other things the Notice advises "This is official notice of your tax rate determination. If you disagree with the determination you may file a written protest, which must include a short concise statement of the facts and grounds for disagreement. To be considered timely, the protest must be postmarked on or before the protest deadline date listed on this notice." The Determination listed the protest deadline date as January 2, 2012.
- 3. Although the *Unemployment Compensation Tax Rate Notice* contained the notice of the Petitioner's right to appeal, the Petitioner did not read that portion of the determination and was not immediately aware that the Petitioner could file a written protest.
- 4. The Petitioner filed a written protest by mail postmarked February 17, 2012.

Conclusions of Law:

- 1. Section 443.141(2)(c), Florida Statutes, provides:
 - (c) *Appeals*.--The Agency for Workforce Innovation and the state agency providing unemployment tax collection services shall adopt rules prescribing the procedures for an employing unit determined to be an employer to file an appeal and be afforded an opportunity for a hearing on the determination. Pending a hearing, the employing unit must file reports and pay contributions in accordance with s. 443.131.
- 2. Rule 73B-10.035, Florida Administrative Code, provides;
 - (1) Filing a Protest. Protests of determinations of liability, assessments, reimbursement requirements, and tax rates are filed by writing to DOR of Revenue in the time and manner prescribed on the determination document. Upon receipt of a written protest, DOR will issue a redetermination if appropriate. If a redetermination is not issued, the letter of protest, determination, and all relevant documentation will be forwarded to the Office of Appeals, Special Deputy Section, in DEO for resolution.
- 3. Rule 73B-10.035(5), Florida Adminsitrative Code, provides:
 - (a)1. Determinations issued pursuant to Sections 443.1216, 443.131 and 443.1312, F.S., will become final and binding unless application for review and protest is filed with DOR within 20 days from the mailing date of the determination. If not mailed, the determination will become final 20 days from the date the determination is delivered.
- 5. The determination was mailed to the Petitioner's correct address of record on or before December 13, 2011, and was received by the Petitioner. The Petitioner's protest was mailed after the protest deadline date. Thus, the determination has become final.

Recommendation: It is recommended that the Petitioner's protest of the determination dated December 13, 2011, be DISMISSED due to lack of jurisdiction.
