1A

Cecil Commerce Center Mega Site Access Roadway

Construction of a new,1.5 mile, access roadway for the 600-acre City-owned Mega Site, at Cecil Commerce Center. Cecil Commerce Center is a master planned 6000-acre industrial park owned by the City of Jacksonville. The Cecil Commerce Center is located in a City-designated Distressed Area and Federal Empowerment Zone.

The proposed roadway is already fully designed and permitted. The project would include clearing of vegetation and installation of roadway drainage infrastructure. The road right-of-way is all owned by the City of Jacksonville. The bidding of the project will begin immediately, if the grant is approved, and the construction phase is estimated to take approximately a year to complete.

1E

The construction of the new roadway will allow the City to better market a prime 600-acre tract of land, located at Cecil Commerce Center. The 600-acre tract of land, which has been valued at approximately \$60 million, is landlocked and very difficult to access with a vehicle. The subject parcel has been certified as a "Mega Site" by McCallum Sweeney, an industry leader in industrial development assessments. The Mega Site also has a 3+ mile old railroad bed, which the City plans on collaborating with CSX on the finding funding options to bring it back online, at some point in the future. CSX has added the Cecil Mega Site to their "Select Site" list, which helps with marketing the site to large industrial users that need rail access to a Class 1 rail line. Overall, the Cecil Commerce Center has been successful attracting companies such as Bridgestone, GE, Fed Ex and Amazon, all of which have established manufacturing and distribution facilities just south of the Mega Site.

Florida State College at Jacksonville (FSCJ) has been a key partner throughout over the past decade that the city has been developing the park. In addition to its general education class offerings, The FSCJ campus at Cecil has state-of-the art programs and facilities for its schools of aerospace and logistics, which include flight simulators and a truck driver training course. FSCJ's on site facilities and programs have been credited with helping attract such a wide array of great companies to the park.

1F

In recent years, the City has been approached by multiple site selectors, representing large manufacturing companies, who expressed interest in the Cecil Mega Site. The City has been informed by those various site selectors and other real estate professionals that not having a formal access road to the Mega Site was one of the primary reasons for Cecil not being the final site chosen for some very large industrial manufacturing projects, some with an estimated capital investment exceeding \$1 billion. Developing the subject 600-acre mega site could generate substantial new tax revenue and attract one or multiple end-users, that would help attract thousands of jobs to an economically distressed part of Jacksonville, and the abutting counties.

2C

The proposed roadway will be in the northern portion of the Cecil Commerce Center, in close proximity to a high speed, I-10 interchange.

2J

The City has just completed the design, permitting and wetland impact credit allocation phases of the project, which total approximately \$1.5 million. The City will also contribute an additional \$700,000 to help complete the \$8.2 million project.

3A & B

In total, the City of Jacksonville will invest \$2,200,000 of the overall \$8,200,000 road project, if the State grant request for \$6,000,000 is fulfilled. The City has already spent \$900,000 on design and permitting of the proposed roadway, and is prepared to utilize \$600,000 worth of wetland credits, owned by the City, to offset the proposed wetland impacts. The City is also prepared to match the grant with an additional \$700,000 of City funds, to help cover the projects overall construction costs.

3C

If the \$6,000,000 grant is approved, the City's Office of Economic Development would file legislation immediately with City Council to obtain their approval for the acceptance of the State grant. If City Council approves the grant request, then the City will immediately prepare a bid package to be advertised for the project. Road construction is expected to take approximately 12 months.

4A

If the \$6,000,000 in State grant funds are awarded to the City of Jacksonville, the City's Office of Economic Development will prepare legislation related to the proposed grant, and bring it for approval the Jacksonville City Council. City Council will need to approve the legislation before the City can execute the grant agreement.

4Bi

The Jacksonville City Council meets every two weeks, which should allow for the approval of the proposed legislation to be completed in a timely manner.
