# ORDER OF REEMPLOYMENT ASSISTANCE APPEALS COMMISSION

This case comes before the Commission for consideration of an appeal of the decision of a reemployment assistance appeals referee. The referee's decision advised that a request for review should specify any and all contentions of error with respect to the referee's decision, and that contentions of error not specifically raised in the request for review may be considered waived. The Commission has jurisdiction pursuant to Section 443.151(4)(c), Florida Statutes.

The Commission's review is generally limited to the issues before the referee and the evidence and other pertinent information contained in the official record. The referee has the responsibility to develop the hearing record, weigh the evidence, judge the credibility of the witnesses, resolve conflicts in the evidence, and render a decision supported by competent, substantial evidence. The Commission reviews the evidentiary and administrative record and the referee's decision to determine whether the referee followed the proper procedures, adequately developed the evidentiary record, made appropriate and properly supported findings, and properly applied the reemployment assistance law established by the Florida Legislature. The Commission cannot reweigh the evidence and the inferences to be drawn from it. Further, absent extraordinary circumstances, the Commission cannot give credit to testimony contrary to that accepted as true by the referee.

Having considered all arguments raised on appeal and having reviewed the hearing record, the Commission concludes that the referee sufficiently followed the proper procedures and the case does not require reopening or remanding for further proceedings. The referee's material findings are supported by competent, substantial evidence in the record. The referee also correctly applied the law in deciding the case.

While the claimant was a long-term employee without any previous disciplinary actions, the employer established the claimant violated its policy prohibiting "appearing to sleep or doze at any point in time while working as a crew member," which was a class I violation that could result in immediate discharge, and could result in serious consequences for the employer. As a working flight attendant, the claimant was responsible for being aware of events on the flight and taking necessary actions to ensure the safety and health of the passengers. For that reason, FAA regulations strictly govern the hours flight attendants can work to ensure alertness. 14 C.F.R. §121.467. FAA regulations require an air carrier to monitor flight personnel fatigue. 14 C.F.R. §121.473.

The evidence and findings in the case reflect that the claimant's drowsiness was not a one-time occurrence. The employer produced evidence, either first-hand or second-hand, of three incidents of drowsiness or sleepiness within seven days. The prior incidents explain why the employer was investigating the claimant on August 30, 2018. There was no indication that the claimant asked for a schedule adjustment or a day off to address ongoing problems with fatigue. Under the factors outlined in R.A.A.C. Order No. 15-01579 (July 30, 2015),<sup>1</sup> we conclude that the claimant's behavior constituted misconduct under subparagraphs (a) and (e) of Section 443.036(29), Florida Statutes. We do so despite our recognition of the claimant's long service. A period of long, satisfactory service usually results because an employee habitually acts in accord with the employer's interests, and in such cases the trier of fact may properly consider that service to draw inferences regarding the claimant's motivations and actions during the incidents at issue. However, like any inference, such an inference can be overcome by contrary evidence. The evidence in this case was sufficient to objectively establish violations of an important safety rule. Accordingly, the referee properly held the claimant was discharged for misconduct connected with work.

#### DECISION OF APPEALS REFEREE

Important appeal rights are explained at the end of this decision.

**Issues Involved:** SEPARATION: Whether the claimant was discharged for misconduct connected with work or voluntarily left work without good cause as defined in the statute, pursuant to Sections 443.101(1), (9), (10), (11), (13); 443.036(29), Florida Statutes; Rule 73B-11.020, Florida Administrative Code.

Findings of Fact: The claimant began working for the employer on July 17, 1998. The claimant last worked for the employer as a flight attendant.

The claimant was made aware of the employer's policy that considers the appearance of being asleep on the job or to "doze at any time while serving as a working Crew Member..." a Class I violation that generally results in a minimum thirty day suspension, up to and including termination of employment" for the first violation and termination for the second violation.

On August 24, 2018, the employer received a verbal report from another employee that the claimant had fallen asleep so hard on a flight that she was slumped over. The report caused the employer to have an unannounced in-flight supervisor board the claimant's flight on August 28, 2018. The in-flight supervisor observed the claimant, while the plane was on decent, bobbing in and out of sleep while seated. The supervisor noticed that the claimant did not become alert until a passenger had an emergency. At that time, the employer launched a further investigation into the matter. The employer's assistant base manager spoke to the claimant on August 30, 2018. He noticed that the claimant, after she had departed from a flight seemed lethargic, fatigued, drowsy with slurred speech. The claimant had admitted to taking medication, but that the medication was non-drowsy. The employer determined that the claimant's actions were in violation of its policies. The employer discharged the claimant on September 6, 2018.

**Conclusion of Law:** As of June 27, 2011, the Reemployment Assistance Law of Florida defines misconduct connected with work as, but is not limited to, the following, which may not be construed in pari materia with each other:

a. Conduct demonstrating conscious disregard of an employer's interests and found to be a deliberate violation or disregard of the reasonable standards of behavior which the employer expects of his or her employee.

b. Carelessness or negligence to a degree or recurrence that manifests culpability, or wrongful intent, or shows an intentional and substantial disregard of the employer's interest or of the employee's duties and obligations to his or her employer.

c. Chronic absenteeism or tardiness in deliberate violation of a known policy of the employer or one or more unapproved absences following a written reprimand or warning relating to more than one unapproved absence.

d. A willful and deliberate violation of a standard or regulation of this state by an employee of an employer licensed or certified by this state, which violation would cause the employer to be sanctioned or have its license or certification suspended by this state.

e. A violation of an employer's rule, unless the claimant can demonstrate that:

- 1. He or she did not know, and could not reasonably know, of the rules requirements;
- 2. The rule is not lawful or not reasonably related to the job environment and performance; or
- 3. The rule is not fairly or consistently enforced.

The record and evidence in this case shows that the claimant was discharged for being inattentive to job duties, and appearing to be asleep on the job.

The employer provided evidence that the claimant was observed going in and out of sleep on the flight of August 28, 2018. The claimant denied being asleep in each instance. The claimant admitted that she was resting her head with her eyes intermittingly closed. Yet, the employer also received a verbal report of the claimant sleeping and the employer's assistance base manager personally witnessed the claimant in a lethargic state.

Regardless of whether the claimant was actually sleeping or lethargic in these instances, the employer provided competent substantial evidence that the claimant was not being attentive to her job duties until the passenger had their emergency on August 28, 2018 and that she was in a lethargic state on August 30, 2018.

An employer has the right to expect employees to be attentive when performing their duties, or to be informed of reasons affecting their inability to perform. Although the claimant testified that she was resting because of her back, at no time did the claimant inform a supervisor that she felt unwell or that she could not perform her job duties. In light of the fact that the claimant was made aware of the employer's policies, the claimant neglected her job duties of awareness and appeared to be asleep or dozing off. The claimant's conduct constitutes misconduct within the meaning of the law. The claimant is disqualified from the receipt of benefits.

The hearing officer was presented with conflicting testimony regarding material issues of fact and is charged with resolving these conflicts. The Reemployment Assistance Appeals Commission has set forth factors to be considered in resolving credibility questions. These factors include the witness' opportunity and capacity to observe the event or act in question; any prior inconsistent statement by the witness; witness bias or lack of bias; the contradiction of the witness' version of events by other evidence or its consistency with other evidence; the inherent improbability of the witness' version of events; and the witness' demeanor. Upon considering these factors, the hearing officer finds the testimony of the employer to be more credible. Therefore, material conflicts in the evidence are resolved in favor of the employer.

Decision: The determination of the claims adjudicator dated October 5, 2018, is AFFIRMED.

If this decision disqualifies and/or holds the claimant ineligible for benefits already received, the claimant will be required to repay those benefits. The specific amount of any overpayment will be calculated by the department and set forth in a separate overpayment determination, unless specified in this decision. However, the time to request review of this decision is as shown above and is not stopped, delayed or extended by any other determination, decision or order.

A party requesting review should specify any and all allegations of error with respect to the referee's decision, and provide factual and/or legal support for these challenges. Allegations of error not specifically set forth in the request for review may be considered waived.
