Guide on How to Request Monetary Reconsideration

Monetary reconsideration requests may be used to correct wages and/or add wages not reflected in the monetary determination.

If you submit a request and it is denied, you will be advised of the reason for the denial and you will have the right to file an appeal at that time if you believe that the denial is in error. However, be advised that you do have the right to file an appeal without first submitting a Request for Reconsideration.
