ORDER

This matter comes before me for final Department Order.

Having fully considered the Special Deputy's Recommended Order and the record of the case and in the absence of any exceptions to the Recommended Order, I adopt the Findings of Fact and Conclusions of Law as set forth therein. A copy of the Recommended Order is attached and incorporated in this Final Order.

In consideration thereof, it is ORDERED that the determination dated May 7, 2013, is AFFIRMED.

JUDICIAL REVIEW

Any request for judicial review must be initiated within 30 days of the date the Order was filed. Judicial review is commenced by filing one copy of a *Notice of Appeal* with the DEPARTMENT OF ECONOMIC OPPORTUNITY at the address shown at the top of this Order and a second copy, with filing fees prescribed by law, with the appropriate District Court of Appeal. It is the responsibility of the party appealing to the Court to prepare a transcript of the record. If no court reporter was at the hearing, the transcript must be prepared from a copy of the Special Deputy's hearing recording, which may be requested from the Office of Appeals.

RECOMMENDED ORDER OF SPECIAL DEPUTY

TO: Magnus Hines

This matter comes before the undersigned Special Deputy pursuant to the Petitioner's protest of the Respondent's determinations dated May 7, 2013.

After due notice to the parties, a telephone hearing was held on July 9, 2014. The Petitioner, represented by its president, appeared and testified. A financial consultant testified as a witness.

The record of the case, including the recording of the hearing and any exhibits submitted in evidence, is herewith transmitted. Proposed Findings of Fact and Conclusions of Law were not received.

ISSUE: Whether the Petitioner is entitled to waiver of penalty and interest for delinquent reports, pursuant to §443.141(1), Florida Statutes; Rule 73B-10.028(4), Florida Administrative Code.

Findings of Fact:

1. The Petitioner is a corporation which operates a security business.
2. During 2011 and 2012 the Petitioner used the services of a Certified Public Accountant to prepare and file the quarterly reemployment assistance tax reports. During that time the Petitioner was also having cash flow problems.
3. The quarterly tax reports for the first quarter 2011, second quarter 2011, second quarter 2012, and fourth quarter 2012 were filed late. The Department of Revenue notified the Petitioner that late filing penalties were due for each of the tax reports that were filed late.
4. The Petitioner's Certified Public Accountant made a written request that the late filing penalties be abated. By determinations dated May 7, 2013, the Department of Revenue denied the requests for waiver of late filing penalties for the first quarter 2011, second quarter 2011, second quarter 2012, and fourth quarter 2012. The Petitioner's president timely protested the denial of the penalty

waiver on the grounds that the Petitioner entered into an installment payment plan to pay past due taxes, penalties, and interest and that the Petitioner disagreed with the manner in which the installment payments had been applied by the Department of Revenue.

5. Pursuant to the protest filed by the Petitioner a telephone hearing was scheduled to be held November 12, 2013. At the hearing the Petitioner's president stated that the Petitioner did not have the ability to prosecute the appeal at that time due to a pending bankruptcy. The Petitioner's protest was dismissed without prejudice with the stipulation that the Petitioner could reopen the protest no later than June 1 2014. The Petitioner filed a timely request for reopening by letter dated April 16, 2014.

Conclusions of Law:

6. Rule 73B-10.025(1), Florida Administrative Code, provides:
 - (b) Each quarterly report must:
 1. Be filed with the Department of Revenue by the last day of the month following the calendar quarter to which the report applies, except for reports filed by electronic means, which are to be filed as provided in Rule 73B-10.023, F.A.C. However, an employer reporting for the first time is authorized 15 consecutive calendar days from the notification of liability to submit reports for previous calendar quarters without incurring penalty charges; and
 2. Be filed for each calendar quarter during which the employer was liable, even if no contributions are payable. If there was no employment during the calendar quarter to which the report applies, the report must be completed to so reflect.
7. Section 443.141, Florida Statutes provides:
 - (1) Past Due Contributions and Reimbursements; Delinquent, Erroneous, Incomplete, or Insufficient Reports.-
 - (a) Interest. Contributions or reimbursements unpaid on the date due shall bear interest at the rate of 1 percent per month from and after that date until payment plus accrued interest is received by the tax collection service provider, unless the service provider finds that the employing unit has good reason for failure to pay the contributions or reimbursements when due. Interest collected under this subsection must be paid into the Special Employment Security Administration Trust Fund.
 - (b) Penalty for delinquent reports.
 1. An employing unit that fails to file any report required by the Department of Economic Opportunity or its tax collection service provider, in accordance with rules for administering this chapter, shall pay to the tax collection service provider for each delinquent report the sum of \$25 for each 30 days or fraction thereof that the employing unit is delinquent, unless the agency or its service provider, whichever required the report, finds that the employing unit has good reason for failure to file the report. The department or its service provider may assess penalties only through the date of the issuance of the final assessment notice. However, additional penalties accrue if the delinquent report is subsequently filed.
8. Rule 73B-10.028, Florida Administrative Code, provides:
 - (4) Waiver of Penalty and Interest. Pursuant to Sections 443.1316 and 443.141(1), F.S., the Department is authorized to waive imposition of interest or penalty when the employer files a written request for waiver establishing that imposition of interest or penalty would be inequitable, however, the Department will not consider a request for waiver of penalty until the employer has filed all reports due for the five years immediately preceding the request for waiver. Examples of inequity include situations where the delinquency was caused by one of the following factors:
 - (a) The required report was addressed or delivered to the wrong state or federal agency.
 - (b) Death or serious illness of the person responsible for the preparation and filing of the

report.

- (c) Destruction of the employer's business records by fire or other casualty.
- (d) Unscheduled and unavoidable computer down time.
- (e) Erroneous information provided by the Agency or Department; failure of the Department to furnish proper forms upon a timely request; or inability of the employer to obtain an interview with a representative of the Department. In each case, a diligent attempt to obtain the necessary information or forms must have been made by the employer in sufficient time that prompt action by the Department would have allowed the reports to be filed timely.

9. The Petitioner's witness, the Petitioner's president, testified that although the Petitioner was experiencing cash flow problems in 2011 and 2012, she did not know why the quarterly tax reports were filed late. She further testified that the primary purpose of filing the protest was because the Petitioner disagreed with the method that the Department of Revenue used to apply payments made under the installment agreement.
10. The method which the Department of Revenue has used to apply payments under the installment agreement is not the reason that the tax reports were filed late. The penalties for late filing of the tax reports are the result of the Petitioner's failure to file the tax reports by the last day of the month following the calendar quarter to which the tax reports apply, not due to the Petitioner's inability to pay the tax. Since no evidence has been presented to show the reason that the tax reports were filed late, it cannot be determined that good cause exists for late filing.
11. Interest on past due contributions is computed at an interest rate that is set by law and which is applied to all delinquent taxpayers. If the Department of Revenue did not charge interest on delinquent contributions it would result in an interest free loan to the Petitioner. Thus, it has not been shown that imposition of interest on the Petitioner's delinquent contributions is an inequitable event.

Recommendation: It is recommended that the determinations dated May 7, 2013, be AFFIRMED.
