Narratives

Disaster Damage:

Hurricane Michael devasted the Panhandle, damaging or destroying over 340,000 homes. Of those homes that suffered major to severe damage, approximately 21,770 (over 56%) Florida homeowners were low-to-moderate income (LMI) families. Many of these homes will require elevation above base flood elevation, adding significant costs to the recovery phase. Many families have been displaced from their homes and are seeking temporary housing assistance, which is limited due to the storm's impact. The unmet needs assessment provided evidence that Hurricane Michael left devastating impacts on the state of Florida. Businesses have suffered, tourism has declined and labor markets were impacted as well. Hurricane Michael also caused substantial damage to commercial and residential properties.

Recovery Needs:

HUD defines "unmet needs" as those financial resources necessary to recover from a disaster that are not likely to be addressed by other sources of funds by accounting for the various forms of assistance available to, or likely to be available to, affected communities (e.g., projected FEMA funds) and individuals (e.g., estimated insurance) and use the most recent available data to estimate the portion of need unlikely to be addressed by insurance proceeds, other Federal assistance, or any other funding sources (thus producing an estimate of unmet need).1 Florida's current unmet needs across HUD defined focus areas (housing, economy and infrastructure). Findings show substantial unmet recovery needs in the economic sector with significant needs remaining in the infrastructure and housing sectors.

Substantial impacts from Hurricane Michael have produced significant unmet needs across Florida's panhandle. Although each county within the presidentially declared disaster area is still recovering, those directly impacted by Hurricane Michael's storm surge at landfall (Bay, Gulf and Jackson counties) appear to have the largest impacts and remaining unmet needs. Unlike the hurricanes of 2016 and 2017, which largely affected households, Hurricane Michael's strength also took a heavy toll on the region's infrastructure and economy. Significant resources will be required to rebuild and replace damaged homes and communities and ensure their resiliency to future natural disasters.

Overall Progress Narrative:

Housing - Housing Repair Program (HRRP) - 100

FloridaCommerce opened the Rebuild Florida Housing Repair and Replacement Program for Hurricane Michael on January 29, 2021. This program served eligible LMI applicants with rehabilitation, replacement, and reconstruction of Hurricane Michael damaged homes. The program served 12 most-impacted and distressed counties, as identified both by HUD and FloridaCommerce, which include Holmes, Washington, Bay, Jackson, Calhoun, Gulf, Liberty, Franklin, Gadsden, Wakulla, Leon, and Taylor. In July 2023, the program completed construction for all LMI homeowners. As of the close of the program, 979 homes completed construction, resulting in 979 LMI families being returned to decent, safe, and sanitary homes. The program reconstructed 348 single-family homes, replaced 424 manufactured housing units (MHU's), and rehabilitated an additional 207 single-family homes within a span of two years following the launch of the Housing Repair and Replacement Program. To achieve the HUD and State mission of increasing resilience to the nation's housing stock, the program utilized energy efficient and resilient building materials, elevated homes in special flood hazard areas, and purchased the first year of flood insurance for LMI homeowners. The program also completed the administrative closeout process for all 979 projects in compliance with 24 CFR 570.490. FloridaCommerce is committed to providing the best possible customer service to our most vulnerable populations by working with various parties to ensure their disaster recovery needs are met.

Housing - Voluntary Home Buyout - 200

The Rebuild Florida Voluntary Home Buyout (VHB) Program is designed to encourage risk reduction by providing funding for local governments to purchase residential property in high flood-risk areas to help reduce the impact of future disasters. Local government within the federal and state designated, Most Impacted and Distressed (MID), areas were able to apply for funding to acquire single properties or lots that were adjoined or adjacent to each other. Acquired properties must become green space or be earmarked for other hurricane-resilient limited usage. Currently, there are two active and productive agreements funded by Hurricane Michael. Both programs were busy with positive movement/progress during the quarter. The City of Panama City has completed all 21 acquisitions for their program. During this quarter the subrecipient completed one demolition and has been completing the necessary demolition permitting and asbestos surveys for their remaining properties. It is anticipated that the subrecipient will complete all demolitions and prepare for closeout within the next quarter.

During this quarter Bay County has completed all 12 demolitions for their program. Although the subrecipient agreement runs until January 10, 2025, due to efficient completion of project deliverables the Subrecipient is preparing for closeout.

Economic Revitalization - Workforce Recovery Training - 300

Chipola College and Tallahassee Community College (TCC) are conducting training in all of their courses. Chipola College's welding program has seen a substantial increase in interest. They have added an additional class for their upcoming summer session and added an additional assistant instructor to help meet the demand. Chipola College has reached roughly 33% of its training goal. TCC has added training courses in Heavy Equipment Operations, Electrical, Welding, and HVAC to their offerings. TCC is currently at roughly 42% of their training goal. Tallahassee Community College (TCC) completed three cohorts of their Pathfinder Academy and one Construction CORE class. TCC completed their Fall Semester classes December 8, 2023, and is scheduled to begin the Spring Semester classes

class. TCC completed their Fall Semester classes December 8, 2023, and is scheduled to begin the Spring Semester classes January 22, 2024. As of December 31, 2023, TCC has had a total of 26 individual students participate in training. As of December 31, 2023, a total of 73 individual students have participated in the WRTP for Hurricane Michael.

Economic Revitalization - Hometown Revitalization Program - 400

All 24 of HRP's contracts are executed and have received environmental exemptions, with 10 having received the Authority to Use Grant Funds. There are currently four projects currently in demolition/construction, six projects in the Construction Procurement stage; 14 in the Environmental Review stage; and seven in the Administrative and Engineering Procurement Stage.



Infrastructure/Calhoun Liberty Hospital (CLH) - 500-600

FloridaCommerce continues to work with the Hurricane Michael subrecipients through each of their infrastructure projects. All of the subrecipients have completed their Environmental Exemptions for exempt activities. Twenty-nine projects are working through the Environmental Review Record. Twenty-four have completed their Environmental Review and received their Authority to Use Grant Funds (AUGF).

Fifteen of the projects that have received their AUGF are still working through project designs and the nine remaining projects that have received their AUGF started drafting their Construction Procurement documents. The Infrastructure Program continued to host trainings on the following subject areas which subrecipients are encouraged to attend: Davis Bacon; Section 3; Storm Tie-Back; and Uniform Relocation Act and Procurements.

Calhoun-Liberty Hospital, the only subrecipient under the Critical Access Hospital Project - Calhoun-Liberty Hospital, is thus far the only subrecipients under the umbrella of the Infrastructure Program to have procured a construction contractor and start construction.

FloridaCommerce provides support to all subrecipients by conducting bi-weekly or monthly phone calls to answer questions and provide guidance regarding the project and Infrastructure Program.

Hazard Mitigation Grant Match Program (HMGP) - 500-600

The HMGMP program has 79 active agreements plus five Phase II agreements in the routing stage and one agreement on hold pending FEMA approval. There have been seven withdrawals. There are currently 19 in active construction; 15 in Phase One (i.e., design and engineering) closeout; 8 in project closeout;

20 in design, 1 procuring professional services; 1 in environmental; 15 in construction procurement.

In the aftermath of the storm, the City's wastewater system is easily overwhelmed by any stormwater and groundwater. This puts the City's entire population at risk for a health crisis as well as threatens to damage property.

The Town of Noma sustained heavy damage to their sewer system during the events of Hurricane Michael. The excessive rainfall caused by Hurricane Michael overwhelmed the wastewater treatment plant and lift stations due to Inflow/Infiltration. The I/I was caused by leaking manhole covers, deteriorated manholes & lift station wet wells, and cracked/deteriorated sewer lines. This project will repair existing sewer system components that were damaged by Hurricane Michael and to replace other system components to ensure continued normal operation of the system. These repairs include the Wastewater Treatment Plant, five lift stations, 2,000 LF of sewer lines, and 50 manholes and manhole covers. These repairs will benefit a service area that is comprised of 80% low-and-moderate income households.

The Town of Noma will also be using \$12,500 of Town funds, \$500 in insurance payments received for Hurricane Michael damage, and \$16,895.27 is FEMA funds.

The Town of Sneads has been awarded \$4,945,145.64 in CDBG-DR funds for the Stormwater Infrastructure Upgrades project. The winds and stormwater of Hurricane Michael wreaked havoc on most, if not all the Town's stormwater infrastructure. Much of the system remains clogged and the remaining portions are overloaded, resulting in yards being flooded and a noticeable amount of standing water on the Town's roadways.

Gulf County has been awarded \$7,012,869.00 in CDBG-DR funds for the Water Transmission and Booster Station project. As a result of Hurricane Michael, a vital coastal water plant has become at high risk of permanent failure, which would disrupt the providing of drinking water and emergency fire services to the affected communities. To prevent permanent failure of the system, Gulf County will relocate two (2) production wells from their coastal proximity to a more inland area. The southernmost areas of Gulf County (Cape San Blas, Indian Pass, Simmons Bayou, and Jones Homestead) will be directly impacted by this water service system upgrade.

Construction will include: (a) upgrading damaged water transmission lines; (b) construction of a booster station; (c) the addition of a ground storage tank; (d) the addition of two (2) high service pumps; (e) the addition of all necessary instrumentation, controls, telemetry, chlorine injection systems; (f) installation of a permanent backup generator; and (g) the construction of a chlorination building.

The City of Port St. Joe has been awarded \$9,799,572.00 in CDBG-DR funds for the 20th Street Lift Station project. The sewer lines and lift stations in the 20th Street area of Port St. Joe sustained damage from Hurricane Michael from a combination of storm surge, debris collecting in wet wells that subsequently damaged electrical wiring and pumps, and debris and water infiltration of sewer lines via manholes. During precipitation events post Hurricane Michael, the City's sewer treatment plant receives on average 7 million gallons per day (MGD) of sewerage which is mostly non-sewer water that has seeped into pipes that are cracked. During non-precipitation days, the City treats on average 1 MGD.

This project will 1) Clean, inspect, and video-record damaged and deteriorating collection system manholes, pipes, and service laterals; 2) Replace 2 lift stations (20th Street and Clifford Sims) and rehabilitate the Hodrick Street lift station; 3) rehabilitate approximately 25,000 linear feet of 8" sewer piping employing a cured-in-place pipe (CIPP) process; 4) removal and replacement of approximately 4,000 linear feet of 8" Vitrified Clay Pipe (VCP); 5) create a temporary sewer by-pass network during construction; 6) redirect and manage vehicular traffic during construction; and 7) replace approximately 20 manholes and 200 feet of 4' sidewalk.
