There is a critical linkage between transportation and economic vitality. The State of Florida is the seventh-largest export state in the U.S with a total of \$82 billion in exported goods and services for 2016. Employment in Transportation and Material Moving Occupations account for 6% of total employment in Florida. Currently, the City of Laurel Hill is not able to take advantage of the employment opportunities in the transportation or material moving industry because of the deteriorating condition of road infrastructure. If the roadways were improved, the City of Laurel Hill has an opportunity to capture a portion of the revenue and employment that currently circumvents their community.

The proposed upgrades will not only bring in revenue from a targeted industry but it will also bring growth and economic recovery within the community. Upgraded infrastructure will entice local development. Laurel Hill has the potential for rapid growth because a large majority of the area is undeveloped. Companies are looking at the quality of a Citys transportation system when deciding where to re-locate or expand. Areas with congested or poorly maintained roads will see businesses relocated to areas with smoother, more efficient transportation systems. The proposed improvements will bring economic recovery to a community that is critical to the health of Laurel Hills economy.
